

GRAN FONDO 360 REGULATIONS

- These regulations define the conditions of participation in the 3 events that make up the Gran Fondo 360 and their characteristics.
- These regulations must be strictly complied with by all people who participate in any of the Gran Fondo 360 events.
- All the technical aspects of each of the tests can be found in the technical sheets on the official website: www.GRANFONDO360.COM.
- These regulations can be corrected, modified and/or improved at any time by the organization, as well as the routes and technical sheets of each test.
- To participate in the Gran Fondo 360 you must be of legal age (18 years or older) on the day of the test.
- Participants explicitly accept, upon registration, the "Declaration of responsibility and physical condition" set forth in these regulations.
- Completing the registration implies full acceptance of these regulations.
- The Gran Fondo 360 are cycle touring, road cycling rides. Therefore, they are non-competitive tests and open to circulation and traffic.
- The main objective of the Gran Fondo 360 Circuit, and its organization, is to offer participants a unique sporting experience.

REGISTRATION

- The place will not be definitively reserved until the participant makes the payment.
- The prices and details of the registration procedure are detailed on the official Gran Fondo 360 website, mentioned above.
- Once the bib number is acquired, it cannot be transferred to other events of the Circuit or to subsequent editions of it.
- The organization reserves the right to cancel the test until the moment before departure if the physical integrity of the participants is in danger for meteorological reasons or for any other reason of a diverse nature.
- The organization is not responsible for extra expenses related to registration in case of cancellation of the test for reasons beyond the control of the organization itself.

REGISTRATION CANCELLATION POLICY

- To guarantee the full return of the registration fee, the organization establishes a cancellation insurance of €10.
- Without prior contracting of said insurance, no claims will be accepted nor will refunds be made.
- If the right to make a claim is exercised less than 10 days before the test, it will not be accepted and no refund will be made.
- If the return is effective, it will have a surcharge of €10 (cancellation insurance) for management costs.

LIST OF TIMES

No time lists will be made since it is a cycle tour and is not competitive.

CONDITIONS OF PARTICIPATION – GENERAL

- Participants participate in the different circuit tests voluntarily and under their own responsibility.
- In compliance with the previous point, the organizer, workers, collaborators, municipality, sponsors and other acting agents are free from any civil liability.
- By registering, participants automatically accept the document "Declaration of responsibilities and physical condition", which informs about the risks involved in participating in the Gran Fondo 360 and excludes the organization from liability in the event of any incident and/or accident.
- By registering, you also accept each of the points of these regulations.
- Failure to comply with one of them means automatic expulsion from participation in any Gran Fondo 360 event.
- It is totally prohibited to join the test without being previously registered. The Organization will in no case be responsible for people who carry out the march without registration.
- The Organization may neutralize the race if it considers it necessary at any time and cancel or modify any section of the route or entire stage if, in consensus with the competent Authorities, it is considered that the development of the test, whether due to inclement weather or some other extraordinary event entails a danger to the physical integrity of the participants.
- If the start could not be given in the event of a pre-emergency or force majeure situation, the stage or race would be suspended without the possibility of any claim against the organizer as it is an issue beyond its powers.

- The Organization will have evacuation services, ambulances and health personnel.
- The Organization may force any runner who is not in adequate physical condition or does not comply with the maximum passage times established at the different control points to withdraw from the race or take an alternative fast route by road.

CONDITIONS OF PARTICIPATION – DAY OF THE TEST

- The Gran Fondo 360 circuit tests take place through sensitive and unique natural environments.
- It is the duty of the organization and the participants not to leave any trace in the environment before, during and after each test. Participants will have to:
- Conserve and preserve the environment.
- Respect the flora and fauna.
- Act responsibly and show exemplary behavior in the face of any adversity.
- Respect the routes and do not go outside the limits set by the organization and others.
- Any action that disrespects the natural environment where the different circuit events take place will have zero tolerance on the part of the organization and will result in automatic and permanent expulsion from the Gran Fondo 360.
- Participants will have to follow the instructions and "rules" that the organization dictates on the day of the test, or the days before if necessary, especially in aspects such as: route, departure, arrival, collection of numbers...).
- Participants must prioritize ethics, camaraderie among themselves and total respect for the environment and the environment above the completion of the test itself, if applicable.
- In case of risk and/or dangerous situations, participants must call one of the two telephone numbers that will be referenced on the bib, and in case of serious emergencies, prioritize the call to the emergency telephone number 112 and subsequently report the situation to the organization.

DEVELOPMENT OF THE TESTS

- Participants must take into account that the marked route where the different Gran Fondo 360 tests take place is open to the rest of road traffic, pedestrians, the free circulation of animals and agricultural vehicles... Therefore, participants must follow the current traffic regulations at all times.
- The organization is responsible for modifying the route, refreshment stations, distance... if it is considered appropriate, and all participants will be informed through official channels.
- Participants must wear their bib number visibly so that the organization can clearly identify them at the control points, refreshment stations and at the finish line.

- During the route, if any participant suffers any incident, whatever it may be, they must notify the organization through the contact telephone numbers that will be referenced on the bibs.
- Each participant must be autonomous in their nutritional management of the test. In any case, the organization will place 'X' refreshment stations along the route, more or less according to the distance.
- Each participant must be autonomous when it comes to managing a possible mechanical incident. In any case, the organization will place basic material at the refreshment stations to facilitate possible basic repairs and an assistance vehicle at the end of the race.
- Once the maximum time to finish the route has passed, all the services of the race will be automatically deactivated.

MANDATORY MATERIALS

• All participants must carry the following mandatory materials that will be verified before the start:

Approved helmet.

Road bike.

Mobile phone with 100% battery.

Official bracelet for the race and clearly visible number on the bike.

WITHDRAWALS

- The organization can establish different cut-off points or controls along the route. Failure to pass these points within the time established by the organization will result in disqualification from the race and therefore the participant will be excluded from the race.
- From the control point, the disqualified participant will be informed of the best option to return to the starting point of the race. The participant must inform the organization of his/her disqualification.
- Participants who decide to withdraw will have to do so preferably at one of the control points or refreshment stations and inform the organization. Only a serious injury will justify the participant withdrawing at any other point on the route. The organization only undertakes to return participants who have left the race at a checkpoint or refreshment point to the starting point of the race.
- The organization reserves the right to return participants to the starting point once the race has finished, in order to guarantee the correct development of the race and its services for the rest of the participants.
